## TONIGHT - Community Feedback session for *Kahnawà:ke Residency Law and Kanien'kehá:ka of Kahnawà:ke Law*

**(Kahnawake – 8, Enniska/February 2022)** The Mohawk Council of Kahnawà:ke (MCK) wishes to remind the community that two (2) regulations drafted under the *Kahnawà:ke Residency Law* (KRL) and (2) regulations drafted under the *Kanien'kehá:ka of Kahnawà:ke Law* will be reviewed for community feedback via online Zoom sessions to take place on the following dates:

- **TONIGHT, Tuesday, February 8, 2022, from 6:30 to 8:00 pm**
- **Thursday, February 10, 2022, from 10:30 am to 12 noon**

An additional feedback period for those who could not attend the online sessions will take place from Friday, February 11<sup>th</sup> until Thursday, February 24<sup>th</sup> at 4pm, at which time feedback on the Regulations can be mailed to the MCK at P.O. Box 720, Kahnawà:ke, J0L1B0, c/o Melanie Konwenni Gilbert, General Manager, Office of the Kahnawà:ke Kanien'kehá:ka Registry, emailed to [feedback@mck.ca](mailto:feedback@mck.ca) or called in by telephone at (450) 638-0500. The Regulations will be made available at that time.

Comments from both virtual sessions and mail/email/telephone will be compiled and posted for community input for 30 days, beginning on Monday, February 28<sup>th</sup>, until Wednesday, March 30<sup>th</sup> at 4pm. After the 30-day review period of the feedback, all recommendations received will be compiled for review and acceptance by Chief and Council.
