Unofficial Notice of the Nominees

For immediate release

(Kahnawake – 2 Ohiarí:ha / June 2012) Nominations for Grand Chief and Council Chief were collected today by Electoral Officer Timmy Norton at the MCK Social Development Unit between 10am and 12pm.

The unofficial nomination list was distributed shortly after 12pm by Electoral Officer Timmy Norton. Four community members were nominated for the position of Grand Chief; twenty three community members were nominated for the 11 positions open for Council Chief.

All the unofficial nominees' names will run through a vigorous background check by the Kahnawake Peacekeepers, The Court of Kahnawake and the Membership Department.

The deadline for all nominated to submit their documentation is on Tuesday, June 5th, at noon.

The official nomination list will be released within seven days of nomination day, but Norton expects that it should be ready by Wednesday, June 6th, 2012.
